**Chairman Dechamps called the meeting to order at 7:30 pm.**

**1 Review and Take Action on June meeting minutes**

Motion made by Supervisor Jacobs to approve the special town board meeting of May 15<sup>th</sup>, 2012 regarding road bids and Dyckesville Sanitary District Representative Compensation. Second by Supervisor Dequaine. Motion Carried. 3-0

Motion made by Supervisor Dequaine to approve the minutes of June 12, 2012 with a second by Supervisor Jacobs. Motion Carried. 3-0

**2. Review Planning Commission minutes**

Motion made by Supervisor Jacobs to approve the Planning Commission minutes of 6-19-12. Second by Supervisor Dequaine. Motion Carried. 3-0

**3. Review Board of Appeals minutes – no meeting was held**

**4. Review Zoning Administrator Report and Building Inspector Report**

Motion made by Supervisor Jacobs to approve the Zoning Administrator report dated 6/12/12 through 7/09/12. Second by Supervisor Dequaine. Motion Carried. 3-0

**5. Wisconsin Working Lands Initiative/Letter to State Representative**

Chairman Dechamps explained the State requires 25% of the eligible participants in the Working Lands Initiative program to be inspected for compliance. Out of the 25% that were recently inspected, there were no property owners in full compliance. Chairman stated approximately 800 eligible property owners were inspected. He stated the Counties must absorb the cost for the inspections. Chairman Dechamps would like the Town Board to send a letter to the state representatives to request the Wisconsin Working Lands Initiative to be abolished and come up with a different plan. Discussion held.

Motion made by Supervisor Jacobs to draft and send a letter to the State Representatives to abolish the program. Second by Supervisor Dequaine. Motion Carried. 3-0

Clerk will draft a letter and mail to our Representatives in the Legislature Senator Frank Lasse and Assembly Representative District 1 Garey Bies.

**6. Town hall Carpet**

Motion made by Supervisor Jacobs to get prices for new carpet and have it installed from the front door of the town hall and in the room to the west. Second by Supervisor
