Chairman Dechamps called the meeting to order at 7:05 pm.

Opened the meeting with the Pledge of Allegiance

Clerk verified proper posting.

1. Review and Take Action on June meeting minutes

Motion made by Supervisor Dequaine to accept the minutes as presented with a second by Supervisor Jacobs. Motion Carried. 3-0

2. Review Planning Commission minutes

Motion made by Supervisor Jacobs to accept the Planning Commission minutes from June 21, 2011. With a second by Supervisor Dequaine. Motion Carried. 3-0

Discussion held regarding a moratorium on all future stands, tents, carts, pushcarts or non-permanent structures from which direct sales are conducted. This will be put on the August agenda.

3. Review Board of Appeals minutes – no meeting held

4. Review Zoning Administrator Report and Building Inspector Report

Motion made by Supervisor Dequaine to accept the Zoning Administrator report dated 6/14/11 through 7/12/11 and the Building Administrator report dated 6/01/11. Second by Chairman Dechamps. Motion Carried. 3-0

Motion made by Supervisor Jacobs to postpone the regular meeting and return to the public hearing for Mr. Dufek. Second by Supervisor Dequaine. Motion Carried. 3-0
Time was 7:20 pm.

Motion made by Supervisor Jacobs to reopen the regular meeting at 7:25 pm. Second by Supervisor Dequaine. Motion Carried. 3-0

5. Town hall roof

Chairman Dechamps stated the roof of the town hall is in very poor condition. The roof on the front half of the building is curling and the back half of the roof is leaking. Chairman will get a rough dollar estimate to replace. The issue of repair will be discussed at a future meeting.

6. Any Other Business

Motion made by Supervisor Jacobs to open the floor with a second by Supervisor Dequaine. Motion Carried. 3-0

David and Kalli Vissers of Cty Hwy K were present to apply for a sign permit; the Board stated they needed to contact the Zoning Administrator, Gary Jonet to apply for the

permit. The Vissers also stated they are waiting for state permits to operate a food stand in front of their residence on Cty Hwy K.

Bob Geyer stated he received a phone call regarding concerns of excessive speed of trucks on County Hwy P.

It was also stated County Hwy K has trouble with vehicles violating the speed zone. Chairman stated the Town could enforce only if we had a police officer who was a member of our Joint Municipal Court System and the speed and violations were included in our Code of Ordinance. It was further discussed that the Brown County Sheriff's Department is responsible for patrolling the area. It was recommended that all future concerns of speed violations should be directed to the Brown County Sheriff's Department. John Metzler questioned if the concealed weapon law was going to affect the town in any way or if there should be any regulations stated in our ordinances. Bob Geyer commented that the concealed weapon law already covers many public areas such as churches, parks, schools, etc.; he stated there are more guns carried illegally on the streets than legally. It was further stated that some public establishments may be posting signs to prohibit weapons on the premise. Discussion held.

Motion made by Supervisor Dequaine to close the floor with a second by Supervisor Jacobs. Motion Carried. 3-0

7. Clerk and Treasurer Reports

Treasurer read report – Total monies on hand as of June 30, 2011 equals \$274,350.03

Motion made by Supervisor Dequaine to accept the Clerk and Treasurer financial reports. Second by Supervisor Jacobs. Motion Carried. 3-0

8. Pay Bills

Motion made by Supervisor Dequaine to review the vouchers and pay the bills. Second by Supervisor Jacobs. Motion Carried. 3-0

9. Adjourn

Motion made to adjourn by Supervisor Jacobs with a second by Supervisor Dequaine. Motion Carried. 3-0 Adjourned at 8:45 pm.
